- A. The suggested guide to submit Form of Acceptance and Transfer for Holders of Damansara Holdings Berhad **whose Offer Shares have been credited into their CDS:**

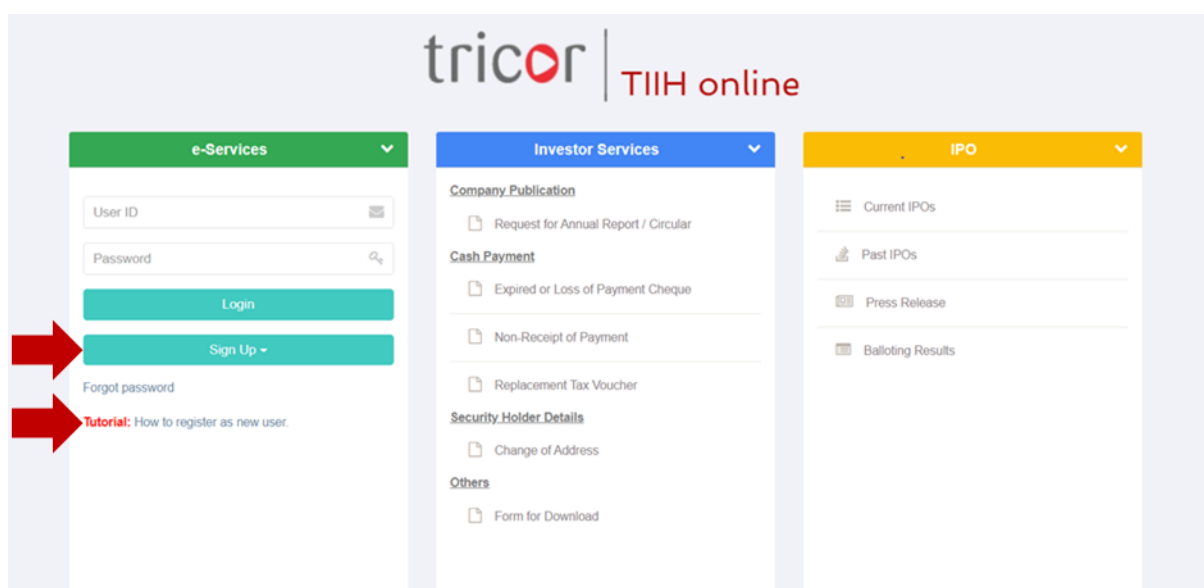
Download Offer Document and Form of Transfer and Acceptance at <https://jcorp.com.my/>.

If you wish to accept the Offer, please contact your stockbroker to process for the transfer of Offer Shares to Absolute Ambient Sdn Bhd's CDS account. The CDS account details are contained in the Form of Acceptance and Transfer.

Upon completion of the transfer of Offer Shares, you will be given a **transfer reference number** by Bursa Depository, as evidence that the transfer has been effected. The transfer reference number needs to be filled-up in the Form of Acceptance and Transfer.

Complete the Form of Acceptance and Transfer. You can submit your acceptance via the Registrar's online platform at <https://tiih.online/>.

Please register as user at <https://tiih.online/>. Follow the instruction in the tutorial video on how to register as new user.



Upon verification of your account, you will receive email approval from TIIH Online, please activate the account, change your new password. Please log in to access the Corporate Exercise / Event.



Use the filter to look for Damansara Holdings Berhad. Click 'Next' button and follow the rest of the instructions to complete the submission of the Form of Acceptance and Transfer.
